Student must submit a signed parish participation card with this enrollment contract in order to qualify for the Catholic rate.

Payment must be made through the SMART Automatic Tuition Payment Plan.

I understand that if the student I am responsible for is a senior and I pay monthly, I am required to have a 10-month payment plan beginning in July 2017 and ending in April 2018.

It is further agreed that enrollment, as specified within this Enrollment Contract, may be cancelled in writing prior to June 30, 2017 and that **my reservation fee will be forfeited.**

If the student is withdrawn or dismissed, I understand that I am responsible to pay my annual amount owed (see schedule below), plus any additional fees or costs accrued from the start of school:

- Withdrawn or dismissed between Aug 9, 2017 and Oct 7, 2017 – 25% of Tuition and Lunch Fee
- Withdrawn or dismissed between Oct 8, 2017 and Dec 15, 2017 – 50% of Tuition and Lunch Fee
- Withdrawn or dismissed between Dec 16, 2017 and Mar 3, 2018 – 75% of Tuition and Lunch Fee
- Withdrawn or dismissed between Mar 4, 2018 and May 25, 2018 – 100% of Tuition and Lunch Fee

I understand upon withdrawal or dismissal all outstanding balances will be due to Benedictine Military School.

Students will not be allowed to attend school if their account is more than 45 days past due.

I understand that I am responsible for any outstanding balance on the student’s account.

I further understand that if there is an outstanding balance on student’s account as of May 26, 2018, student will not be allowed to participate in any summer activities or sports until the outstanding balance is paid in full.

I further understand that if there is an outstanding balance on the student’s account on sign-in day in August, 2017, that student will not be allowed to register or attend classes until the past due balance is paid in full.

If at any time it is determined by the Principal and/or Headmaster that the student is not in good standing academically and/or behaviorally and/or financially, the administration may require you to withdraw your son.

I understand that in signing this enrollment contract for the 2017-18 academic year, I accept and agree to be governed by the rules and regulations of the School as stated in the current student handbook and the rules concerning payment of fees as referred to above.

Furthermore, I agree to the policy of the school that **no student's grades or transcripts will be released to any other school/college, no diploma will be awarded**, nor will student (if a senior) be allowed to participate in any graduation activities/ceremonies unless my account has been paid in full.
