_____ I understand if the student I am responsible for is a senior and I pay monthly, I am required to have a 10-month payment plan beginning on July 5, 2018 and ending on April 5, 2019.

_____ I understand I am responsible for any outstanding balance on the student’s account.

_____ I understand the student will not be allowed to attend school if the account is 45 days past due. Multiple late payments will result in administrative review.

_____ I understand upon withdrawal or dismissal all outstanding balances will be due to Benedictine Military School.

_____ **I understand if the student is withdrawn or dismissed, I am responsible to pay my annual amount owed (see schedule below), plus any additional fees or costs accrued from the start of school:**

- Withdrawn or dismissed between Aug 3, 2017 and Oct 5, 2018 – 25% of Tuition and Lunch Fee
- Withdrawn or dismissed between Oct 6, 2018 and Jan 2, 2019 – 50% of Tuition and Lunch Fee
- Withdrawn or dismissed between Jan 3, 2019 and Mar 8, 2019 – 75% of Tuition and Lunch Fee
- Withdrawn or dismissed between Mar 9, 2019 and May 24, 2019 – 100% of Tuition and Lunch Fee

_____ I understand if there is an outstanding balance on the student's account as of May 24, 2019, the student will not be allowed to participate in any summer activities or sports until the outstanding balance is paid in full.

_____ I understand if there is an outstanding balance on the student's account on sign-in day, August 2018, the student will not be allowed to register or attend classes until the past due balance is paid in full. **No** balance will be allowed to roll over.

_____ I understand if at any time it is determined by the Principal and/or Headmaster that the student is not in good standing academically and/or behaviorally and/or financially, the administration may require the student to withdraw.

_____ I understand in signing this enrollment contract for the 2018-2019 Academic Year, I accept to be governed by the rules and regulations of the School as stated in the current student handbook and the rules concerning payment of fees as referred to above.

_____ I agree to the policy of the school that **no student's grades or transcripts will be released to any other school/college, no diploma will be awarded**, nor will the student (if senior) be allowed to participate in any graduation activities/ceremonies unless the student account has been paid in full.
